The Postgraduate Medical Education Committee considered the Assessment Report (16.05.2018) and decided to recommend to the Central Government that the recognition of MD(General Medicine) qualification for 4 seats granted by Vinayaka Missions University (Deemed), Salem, Tamil Nadu in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem, Tamil Nadube renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.
